### **Hebron Beach Committee** **Minutes of Meeting October 18, 2017**

The meeting was called to order by Cindy Newton at 7:07 PM.

A review of the May 16, 2017 minutes was discussed. A motion was made to approve the minutes by Edward Holbert, seconded by Cindy Newton. The motion passed unanimously.

The 2017 budget was reviewed. Total actual expenses so far for 2017 were \$6,848 under budget by \$2,402.00. Discussion ensued on purchasing a swim line roller reel that will make it easier to take up the swim line in the fall and set up in the spring. Also discussed was purchasing new swim line  $\frac{3}{4}$ " and new buoys 8" X 5". Edward Holbert will get prices and provide them to Cindy as soon as possible.

Cindy indicated that spring cleanup went very well. Camp Berea was very helpful in the spring cleanup and Cindy will send them a thankyou letter.

Alan is going to see if Mark Braley will do the fall cleanup cost should be around \$400.00. Cindy Newton made a motion for Mark Braley to do the fall cleanup and Edward Holbert seconded the motion. Motion passes unanimously.

The attendant's compensation was under budget by \$834.90 and the \$5,000 would be adequate for the 2018 budget. There was much discussion on monitoring those individuals that walk to the beach from the Gray Rock Parking area and boaters that come ashore to use the beach and rest rooms. Most of these people are not taxpayers in Hebron or residents of Hebron. Cindy made a motion to add two new signs; one to address the walkers coming on to the beach and one

that would be located on the beach to address the issues with the boaters. These signs will be 2' x 3' and indicate that the beach is a private town beach and is for the taxpayers and residents of Hebron. This was seconded by Ed and the motion passed unanimously.

The erosion issue was addressed. Stan Newton volunteered to put back rocks that have disappeared by the break water. This should fix the issue of the erosion on the beach.

There is an old gas trimmer that is not working and it was decided that it could be ditched.

Cindy indicated that the printing cost of the beach permits when down. It was also mentioned that the new picnic table was setup this season.

With no further business Cindy Newton made a motion to adjourn at 8:10 PM, seconded by Edward Holbert. The motion passed unanimously.
