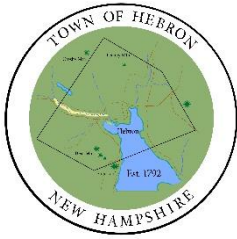

Hebron Historic District Commission

Minutes of Meeting November 13, 2018

Historic District Commission Members Present: Ron Collins, (Chair), David Brittelli, (Vice Chair) Chris Laux (Member), Roger Larochele (Planning Board Chair), Paul Hazelton (Select Board Representative), Carol Bears (Secretary).

The meeting was called to order by Ron Collins,(Chair) at 7:03 p.m. Ron Collins introduced the newest member Chris Laux to the board.

Minutes: The minutes of the October 9, 2018 were reviewed. A motion was made by David Brittelli to approve the minutes and seconded by Roger Larochele. The motion passed in the affirmative.

Old Business: The Selectmen were thinking about withdrawing from the Certified Local Government Program. Ron Collins and David Brittelli are trying to discourage them from doing that as there are many grants available to the town for projects in the Historic District.

New Business:

Ron Collins talked about some of the properties that are currently being considered for the National Historic Register. The first one was David Brittelli's farm; Howard Oerdel's property on George Road; Six Chimney's on Mayhew Turnpike; Peter Chamberis property on North Shore Road and the Daniel Walker house on Mayhew Turnpike by Auto Air.

There is a new Inventory Form that is to be used for new property added to the State Historic District.

The Budget for 2018 was addressed. One of things that did not get done was the Welcome to the Hebron Historical District as the signs have not been done at this time. This had a budget of \$2,250.00. It was decided that that Ron would look into getting these signs started before the end of the year.

Ron included a draft of the Annual Report for HDC that will go into the Town Report for 2018. He would like members to review and make other suggestions for the report.

Paul Hazelton talked about the State requirements to be a member of the Historical District Commission. The State has some suggested requirement for individual's serving on the board but there are no actual qualifications to be a member.

Roger Larochelle talked about the space in the Academy Building for the Hebron Historical Society to display some of the historic materials and hold its meetings. Roger asked what would happen to the Town Clerks building after the Academy Building was completed. There was some discussion about the Hebron Historical Society using the space to house the Hebron Historical Society materials that are currently located at different places. It was also suggested that if the building could be connected to the Library so that they would have more room and also have a bathroom facility available. This is something that the grants from the CLG could help the Town with.

As there was no further business a motion was made by Chris Laux and seconded by David Brittelli to adjourn the meeting at 7:40 p.m. The motion passed unanimously.
